

- <u>Multiple businesses with same owner:</u> Membership dues of company with largest number of employees follow the above formula. Dues for remaining businesses will be calculated at ½ of fee scale per number of employees per business.
- Dues must be paid on time each year. Members paying late will not be given a new due date. The amount will be applied to the members annual due date. The Chamber year runs from October 1st September 30th.
- Membership dues to the Chamber of Commerce may be tax deductible as an ordinary and necessary business expense. Dues paid to the Chamber are not a charitable tax deduction for Federal Income Tax purposes. The Chamber is not a charity, but serves as an advocate organization for area businesses.
